

Accuracy Checking Pharmacy Technician Course Pre-Enrolment Dispensing Log

Introduction

Our Accuracy Checking Pharmacy Technician (ACPT) Course is designed to meet the Association of Pharmacy Technicians UK (APTUK) National Education Framework: Final Accuracy Checking of Dispensed Medicines and Products (2019).

The APTUK framework specifies the **entry requirements** for applicants, including the need for applicants to have "documented evidence to demonstrate they can dispense accurately over the full range of speciality and prescription types at their practice base by means of a 200-item accuracy log."

Why do I need to complete a dispensing log for enrolment?

Before enrolling on our ACPT Course, applicants are required to complete a dispensing log to record 200 items along with supplementary records for any errors identified, and a witness testimony to be completed by their facilitator to confirm their competence. All tasks carried out must be a result of real work activities that have been carried out by the applicant in the workplace.

What is the role of my facilitator?

Your facilitator is a nominated colleague who is suitably trained to carry out final accuracy checks of dispensed medicines in your workplace, they may be a pharmacist or an accredited ACPT. Your facilitator will support you through your ACPT course, their details are confirmed on your enrolment form. They will receive support from Buttercups Training to carry out their role, including assessment guidance.

How do I complete the 200-item Pre-Enrolment Dispensing Log?

Please use the templates in this document to complete your 200-item Pre-Enrolment Dispensing Log. You can record 10 entries on each page. You must complete a **self-check for each item** to ensure it has been dispensed accurately. Your facilitator can delegate the final accuracy check of your dispensed items to a suitable final accuracy checker in your workplace, such as an accredited ACPT or a pharmacist.

You will need to record at least 5 items out of the 200 that require calculations to be completed as part of the dispensing process, for example, calculating the total quantity to supply. You should include records of a range of different formulations.



If you make any **near misses detected by the final accuracy checker or dispensing errors that have reached the patient**, please use the error form to record and reflect on these errors with your facilitator. Remember to exclude any **sensitive and confidential information** that would allow patients to be identified.

Do I need to submit my dispensing log for enrolment?

Whilst you do **NOT** need to submit your 200-item dispensing log to enrol on our ACPT Course, your facilitator will need to complete a declaration on your enrolment form to confirm you have completed this dispensing log. Please keep your Pre-Enrolment Dispensing Log safe, as we may request it for sampling and monitoring purposes when required.

ACPT Course Pre-Enrolment Dispensing Log: Error Log

You will record **near misses** that you have made, either identified in your self-checking process or by the final accuracy checker, and **dispensing errors that you have made** in the Error Log. You will find the template on the following page.

When recording an error, consider its level of impact on patient safety.

Impact on patient care / level of harm	Example
No harm	 No harm or impact on patient care, for example: near miss - impact prevented - identified before reaching the patient dispensing error - impact not prevented - error has reached the patient but the medicine/device has not been taken/used
Low	The error has reached the patient, it results in the patient with minimal harm requiring extra observation or minor treatment
Moderate	The error has reached the patient, it results in the patient with moderate, short-term harm requiring further treatment
Severe	The error has reached the patient, it results in the patient with severe, permanent or long-term harm
Death	The error has resulted in the patient's death
